



ETD Business Meeting Minutes 25 June 2020

The ETD Business meeting was called to order at 5:00pm on June 25, 2020 by Clay Gloster, Jr., Division Chair of ETD via zoom. The following persons were present: (see zoom recording).

Minutes of the previous meeting were distributed electronically prior to the meeting by Robert Garrick. During the zoom session the minutes were scrolled through and reviewed by meeting attendees. ETD minutes of January 2020 were accepted as presented. The motion passed unanimously.

OFFICER and ETD COMMITTEE REPORTS:

Treasurer's Report: David Goodman gave the report. A copy is attached.

David reported the projected balance of the Banking and Accounting Services System (BASS) account as of last year was, \$47,111 as of January 31, 2019.

Comments

The ETD Business Meeting Schedule was reviewed. The McGraw/Berger Award Dinner was cancelled.

The process this year followed the by-laws: the chair managed the abstract review phase, which included sending out a call for reviewers and assigning reviews; communicating, as appropriate, with the vice-chair, reviewers, and authors; contacting Patti Greenawalt, conference coordinator, as necessary; and making final decisions regarding acceptance or rejection.

Moving the conference to virtual created many questions from authors.

Recommendations: Provide more detailed instructions to the reviewers in the call for reviewers. We could improve the quality and consistency of reviews if the instructions were more detailed.

He reported that he periodically sends out reminders on the ETD listserv for people to join ETD.
