### Excerpts from Bylaws about Officer Elections

- Elections for Chair-Elect, Director of the Assessment Exam, and the Treasurer shall be held in **odd**-numbered years. [VI-3]
- Elections for Secretary and Institutional Representatives shall be held in **even**-numbered years. [VI-4]
- Nominations submitted by the Nominating Committee shall be made known to the voting membership of the Association through the means most suitably determined by the Publications Committee on or before **April 1** of each year. [XI-1]
- In the event there is no contest for any office, the election for that office shall take place at the Annual Meeting by voice vote. [XI-3]
- In the event there is more than one nominee for any elective position, the election for that position shall be conducted by means of a ballot sent to all voting members. These ballots shall be distributed **no later than May 15th and must be returned no later than June 1.** [XI-4]
- Membership of the Nominating Committee shall consist of a Chair and at least two other members of the Association. **The Chair of the Nominating Committee shall be the most immediate Past Chair of the Association who is able and willing to serve in this capacity.** Additional members of the Nominating Committee shall be appointed by the Chair of the Association. With the exception of the individual serving in the capacity of Nominating Committee Chair, no member of the Nominating Committee shall be a current member of the Executive Committee of the Association.
